Admission FYJC (XI): 2021-2022 Admission Circular (For DAE Wards only)

Admissions are open for bonafide DAE Employees' wards, who have passed class 10th either in CBSE, MS Board or any equivalent boards. Atomic Energy Junior College, Mumbai offers vocational course (**Skill Based**) in **Electronics, Electrical Maintenance and Computer science** along with other main subjects. The usual science stream has option of Information technology/Languages (Hindi/Marathi). **Commerce stream** is also offered. The admission is based on the guidelines issued by MS Board. Students, passing through CBSE/ICSE/NIOS are expected to submit migration certificate.

Eligibility Norms

- i. Admissions are open only to the wards of the employees of the Department of Atomic Energy, AEES and other units of DAE,
- ii. The criterion for admission are based on the norms framed by the Department of Education, Govt. of Maharashtra and adopted by the Governing Council of Atomic Energy Education Society from time to time,
- iii. Admission to the Candidates from other Boards/States to FYJC in AEJC is purely provisional subject to the approved **Eligibility*** of the applicant from M.S.Board, Mumbai,
- iv. Candidate must have passed in five subjects with English as one of the subject in AISSE/SSCE.
- v. Marks and Subject Criteria :
 - a. For Science and Vocational (on Merit Basis) Minimum pass marks in AISS/SSC Examination and candidate must have passed in Science at AISS/SSCE.
 - b. For Commerce Minimum pass marks in AISS/SSC Examination.
 - c. Admission for Science, Vocational and Commerce course of **FYJC (Std. XI)** will be strictly on merit and will be restricted to the number of seats that would be available.

Vocational subjects have two papers

Eligibility Certificate*

Candidates, who have passed Class X Exam from other board i.e. other than Maharashtra Board and are seeking admission in FYJC at AEJC, Mumbai are required to submit ORIGINAL filled-in Application form for Eligibility Certificate through AEJC (whenever the same is asked) along with the required enclosures viz.

- a. Copies of (TC/SLC) duly countersigned by appropriate authority in relevant cases as per rules,
- b. Photocopy of original Mark sheet of Class X,
- c. Original Migration Certificate from the board,
- d. Deed of undertaking on the stamp paper at appropriate time as given by the Office, **as per updated norms of the Board.**
- e. Copy of Marks Statement and Passing Certificate should be submitted immediately after receiving from the board**.

The Maharashtra State Board of Secondary and Higher Secondary Education issues a Provisional **Eligibility Certificate** after receiving the above mentioned documents.

It will be obligatory on the part of the students to collect the passing certificate and Migration certificate from the respective School/Jr. College, on receipt of the same from CBSE/ICSE or other state boards and submit the same to **AEJC, Mumbai in time for submission to **Maharashtra State Board of Secondary and Higher Secondary Education, Vashi, Navi Mumbai**, to get the Final Eligibility Certificate. Without Final Eligibility Certificate student/s will not be entitled to appear for the final exams. If they are permitted to take the exams, their results will not be declared and they will not be promoted to **SYJC (Class XII)** without the final **Eligibility Certificate** as per Board rules.

Note:

- i. Those students who opt for Vocational Group must clearly indicate the vocational subject of their **First, Second and Third Preference**. If they don't indicate their **Second and Third Preference**, it will be considered that they do not want any other Vocational subject. If they do not get the subject opted for, against **First Preference**, they will be automatically considered for the **Science Group with Biology**.
- ii. If order of preference of stream is not given, the candidates will be considered only with the option given by him/her. If no option is given, the candidate will be considered for commerce stream only.

Instructions to the students regarding admission

1. Exercise all the options as per your choice given in on line process. Later **no claim** will be entertained for change of choice.
2. After the display of First Merit List, students should pay the fees (on line) for the stream offered, otherwise they will not be considered for better choice in the consecutive lists and no claim will be entertained in this regard thereafter.
3. After the first merit list, if better choice offered in the consecutive lists (Second, third) students should compulsorily move to the next better choice offer, otherwise his/her admission stand cancelled and again he/she will not be considered for the admission in the next phase. Difference of fees, if any, should be paid immediately.
4. Fee structure and amount to be paid is available in Admission Circular (www.aees.gov.in). Misc. Fees is displayed on the AEJC website.
5. Submission of (class X) Original **TC** along with the original fee receipt paid through online in college is mandatory for confirmation of admission. Fee payment through on line alone does not confirm admission. If the confirmed admission is cancelled due to any reason, the Old T.C (class X) will not be issued, instead college will issue new T.C and the claim of fee refund will be as per AEES Refund rules,
6. **No claim of old TC will be entertained, if the admission is cancelled.**

Documents to be submitted in the College Office for confirmation of admission in FYJC (2021-22) :

1. On-line fee payment receipt – Original,
2. One passport size photo,
3. Self Attested Photo copy of Class X Mark sheet,
4. Transfer / School Leaving Certificate – Original, **not to be returned after admission,**
5. Proof of Govt. Accommodation (if applicable)/ Address proof –(Photo copy),
6. Aadhar Card (Photo copy) of the applicant mandatory for address verification,
7. Students coming from other State Boards should submit TC/SLC duly countersigned by Education Department authorities of the State or **as per update on Rules.**
8. Self Attested Photo copy of the caste certificate in case of SC/ST/VJ/NT/SBC & OBC communities in the name of the students issued by Executive Magistrate Tahsildar and revalidated in Maharashtra, if from other state.
9. Self Attested Photo copy of Birth Certificate if the place of birth is not indicated in TC/SLC.
10. Self Attested Photo copies of Certificates of NCC, Scout and Intermediate Drawing Examination, participation in Sports and cultural activities at state/national level and selection in INMO.
11. Employment certificate of either parent serving in DAE units (Original).
12. Undertakings on Fee collection as per the enclosed proforma (Original).
