1. 2. Candidates may note that mere empanelment does not bestow any right to claim employment in AEES.
3. Candidates who will be offered appointment will be allowed to join subject to their satisfying all the eligibility conditions as per AEES Recruitment Notice No. AEES/01/2022 and after having being found medically fit, by an in-house medical panel. Their eligibility will be decided subject to their submitting valid educational qualification certificate/document, Caste certificate, Disability certificate, Income and Assets Certificate for EWS, Police Verification Certificate, No Objection Certificate (as required) etc., in original, for verification, and a copy of each for retention by the Head of the AEC School at their respective place of posting. If it is found that any candidate is not fulfilling the conditions as per AEES Recruitment Notice No. AEES/01/2022, his/her candidature is liable to be terminated/cancelled at any time.
4. The candidates are liable to serve in any of the AEC Schools situated in all over India, as required by AEES from time to time.
5. The aforesaid panels are valid till 19/07/2024 or till the preparation of the next panel, whichever is earlier. AEES, however, reserves the right to extend the validity of the panels in order to fill the advertised vacancies, from among the candidates empanelled in # 1 above.
6. A Wait listed candidate is likely to be considered only in case a candidate from the corresponding select list does not accept the appointment or vacates the post during the validity of the panel.
7. Offer of appointment in respect of Select List candidates of different categories/subjects will be issued in due course as per requirement in AEES and subject to availability of vacancies.

8. The post is offered to an empanelled candidate with an advice to join duty by a particular date. If one fails to do so, the offer of appointment will be treated as cancelled. Thereafter, such a candidate will not have any right or claim in this matter.

10. Records of the candidates not selected will not be preserved beyond six months from the date of publication of select panels.
