MINUTES OF THE COMMITTEE MEETING CONSTITUTED FOR VERIFICATION OF ROSTERS OF ALL TEACHING POSTS (SUBJECT-WISE) AND NON-TEACHING POSTS IN AEES UNDER DIRECT RECRUITMENT AND PROMOTION QUOTA.

Principal, AECS-4, Mumbai and Liaison Officer, Special Cell SC/ST & PwBD, AEES constituted committee vide email dated 19/05/2025 for verification of rosters of all teaching posts (subject-wise) and non-teaching posts in AEES under Direct recruitment and promotion quota updated as on 31/12/2024. The committee met on 21/05/2025 at 1000 hours in Conference Room, 1st Floor, AEES, Western Sector, Anushaktinagar, Mumbai 400 094.

Smt. Roopa M Sawant, AAO(R&V), AEES and Smt. Sukhwinder Kaur Saini, Senior Clerk, AEES, Mumbai were also present in the meeting.

The Committee examined the Reservation Roster and Register of all teaching posts (subject-wise) and non-teaching posts in AEES under Direct recruitment and promotion quota updated as on 31/12/2024.

The observations are as follows:

1. The rosters of the following posts are not required for the details mentioned against it.

- 2. The category of Smt. Sarita Yadav, PRT(SS), AECS-2, Rawatbhata was mentioned General in the Roster for the post of PRT till the year ended 31/12/2023. However, it was noted that she belongs to OBC category which is entered in her Service Book. She has submitted OBC Certificate dated 06/09/2005 at the time of her joining in AEES as Stipendiary Teacher in support of her claim. Hence, competent authority in AEES accorded approval to change the category of Smt. Sarita Yadav as OBC instead of General.
- 3. With reference to the grievance of Smt. Ashwini Netrekar and Smt. Roopa M Sawant, AAO, the committee verified the rosters for the post of Assistant and Assistant Administrative Officer respectively under Limited Departmental Examination and found in order.
- 4. The rosters for the posts of PGTs, TGTs and PRTs are maintained subject-wise. Committee suggested to maintain Post-wise roster (i.e. all subjects together) instead of subject-wise roster. While maintaining subject-wise rosters, representations of reserved categories are less compared to having the post wise rosters.

Since, the final Reservation Roster/Roster Register prepared for all posts as on 31/12/2024 is in accordance with Government of India Orders, Signature of Dealing Clerk, AAO, AO-III, CAO, Liaison Officer for SC/ST, Liaison Officer for OBC and Liaison Officer for EWS of AEES may be obtained and to upload on AEES website.
